Staff members from Hunterdon Central volunteer their time as chaperones. We hope you will support this event, and we encourage all 2018 graduates to attend. We know our students will have a fantastic time and cherish one last chance to be with all of their classmates.

Events/Activities for the night include:

- a variety of buffet style foods served throughout the entire night and unlimited beverages
- an ice cream sundae bar

Graduates attending PG will be bused directly from Hunterdon Central to Dave & Buster's by Starr Transit Company. If a graduate signs up to attend but does **NOT** board the bus the night of the event, a parent/guardian will be notified prior to our departure.
