

**Hunterdon Central Regional High School  
District-Issued Electronic Device  
Optional Insurance Plan  
2019-2020**

Hunterdon Central Regional High School offers optional insurance for district-issued electronic devices (Chromebooks). If you are interested in purchasing an insurance plan for your student's device, complete the form below and return it with payment to HCRHS Business Office **by September 13, 2019**.

For purposes of this Optional Insurance Plan, "District" is defined as Hunterdon Central Regional High School IT Manager or Designee.

**Plan Term:**

1. This is an annual plan with maximum coverage dates July 1, 2019 – June 30, 2020.
2. Plans purchased after July 1, 2019, will begin on the date of purchase and will be in effect through June 30, 2020.
3. The date of purchase is the date payment is received by the Hunterdon Central Business Office.
4. **THE DUE DATE TO PURCHASE AN INSURANCE PLAN IS SEPTEMBER 13, 2019, FOR COVERAGE OF DEVICES ISSUED AT THE BEGINNING OF THE 2019-2020 SCHOOL YEAR.**
5. Students who are issued devices after September 13, 2019, will have one week from the device issue date to purchase an insurance plan.

**Plan Cost:**

1. The cost of the plan is \$30.00 and is valid for coverage on one device.
2. The cost of plans purchased after July 1, 2019, will not be prorated.
3. Plans are not refundable in the case that the device removed from Student per the "three strikes" rule, Student withdraws from District, or any other reason.

**Plan Coverage:**

1. The District determines whether a device is repairable or must be replaced, based on the extent of damage.
2. Repair or replacement is the responsibility of the District. Student/Family is not authorized to perform repair/replacement. Violations of this condition result in termination of the insurance plan.
3. Plan covers up to two repairs of a single device.
4. Plan covers only one replacement due to damage or loss. If a device replacement is necessary, the device is covered and the plan terminates.
5. In the case of a replacement, Student/Family may purchase an additional plan on the new device within seven days of issuance. Additional plans will be issued at a cost of \$30.00 for one device for the remainder of the school year, through June 30, 2020. Additional plans are not pro-rated.
