SUPT'S REPORT

Superintendent's Report:

- 2020 National Merit Scholarship Finalists – Dr. Moore congratulated Lauren Bruhl, Danielle Serrao, Bowie Shreiber for their achievement and presented certificates of recognition.
- Officer Jack Gale, Class III Officer – Dr. Moore welcomed Officer Gale as Hunterdon Central's second Class III Officer, noting that he recently retired from a near 30 year career in law enforcement.
- National School Counseling Week – February 3-7, 2020 – Dr. Moore recognized the Counselors as heroes as they work tirelessly in support of our students.
- Wellness Presentation

Wellness Partners

Dr. Moore introduced Lesley Gabel of Hunterdon Prevention Resources. Ms. Gabel thanked the Board for its partnership of over 10 years. She described peer-run programs designed to engage youth and improve communication. For the "Drop Your Phone and Talk" day, Ms. Gabel said 723 student put their phones in baskets on lunch tables, giving them a chance to talk to each other the whole lunch period. She said she will continue working with teens on similar projects. Dr. Moore commented there is a fine line between integrating Chromebooks into learning and controlling technology addiction. He said that for the first time in his career, students are talking about needing help putting phones down. Dr. Moore shared a list of agencies with which Hunterdon Central has partnered for its wellness initiatives. He said the district collaborates with experts on public health matters.

Wellness & Mental Health Staffing

Dr. Moore reported that the district has doubled the number of Student Assistance Counselors to one per grade level. He said the number students per counselor is 150 at Hunterdon Central, while the profession recommends no more than 250, the New Jersey average is around 300, and the national average is closer to 500. He reported that Counselors logged over 25,000 encounters with students so far this school year. The district regularly houses school-based therapists from Hunterdon Behavioral Health, and from Traumatic Loss Coalition when we need them. Dr. Moore said security staff are essential to wellness on campus; Hunterdon Central has ten Security Aides, two Class III officers, and one School Resource Officer.

Staff Training & Support

Dr. Moore outlined staff training and support to improve classroom culture through relationship building and stress reduction. He reported 20% swings in critical factors on the culture/climate survey following training. Dr. Moore said the Traumatic Loss Coalition trained all staff to recognize problems in students, and Pure Edge will work with staff on ways to reduce stress. Wellness training will migrate to students next, per Dr. Moore, teaching ways to take mental breaks. Dr. Moore said we must take care of the adults, particularly those who are grieving. The district has implemented an Employee Assistance Program and uses in-house therapists when needed.

District Practices

Dr. Moore said the Board recognized the need for more leadership and created the Dean of Students position to expand the work we have been doing and to quicken the pace. He announced that teachers have been working on changes to grading principles and homework to ensure reasonableness. He said the district is examining discipline and substance abuse policies to afford more protection around students and to prevent feelings of hopelessness. Dr. Moore noted that stress and anxiety often feed the roots of what traditional policies want to punish.

Parent Support

Dr. Moore discussed parent supports, seminars, and the numerous videos on HCTV. He noted that videos of tools for working with stress have been viewed by hundreds with additional programs and videos planned for the near future. Dr. Moore announced a March evening event featuring a parent who lost a child to suicide. He said the program shares a message of hope and service.

Student Involvement

Dr. Moore said he is honored and pleased to have students join us in district wellness projects. He said that as students ask for opportunities, and they will learn from experts. This Friday, Hunterdon Behavioral Health will be on campus

for a program on how to talk to a friend in distress. He shared that students are currently working with Dr. Webb and Mrs. Kurilew to create wellness areas in school. He said Sources of Strength, a student-led support program is being introduced which gives students guidance on how to help their peers who might be in distress and how to refer them for help. This program is well recognized and proven to improve outcomes with students. Dr. Moore said students have also asked for a student wellness day. Supervisor Jesse Spencer has developed a student athlete leadership team to work on student athlete wellness. Dr. Moore reported that Prevention Resources continues to work with students on a variety of topics including anti-vaping and tech addiction, and the Student Assistance Counselors are creating a wellness group for Spanish-speaking students to address alcohol, tobacco, and drug abuse. He said the school will introduce a safety app to contact the Hunterdon Central hotline.

Dr. Moore summarized that the goals of the district wellness initiatives are to provide meaningful relationships with trusted adults, opportunities for service, and enhanced protective factors around our students, guarding them from self-harm and suicide. He said we must figure out how best to remember the students we have lost while balancing the needs of the 2,800. Dr. Moore said we will recognize all students in the yearbook and at graduation, but experts warn that certain actions bring concern for vulnerable students. As we shift our focus to active student wellness and service, he explained that this does not mean we forget our friends; remembrances also happen in faith communities, recreational teams, and families. Dr. Moore shared that the adults at Hunterdon Central are grieving, and the friends you lost are never far from the minds of the adults. He said we remember them every day as we watch over you and as you grow in your ability to care for one another. He praised students for the incredible steps they are taking to change the world.

Dr. Moore said that we are not done, and outlined next steps: the district will continue collaboration with K-8 schools, the faith community, law enforcement, and other community partners. He said we must build a toolbox of resources with common language available to every adult in our community. Dr. Moore said we need a better way to map our system of student care for parents, broader cooperation with K-8 schools, and case management for the whole family of a student in need. Dr. Moore said data of needs will be analyzed and processes to meet those needs will be adjusted, and strategies for de-stressing will continue, as will revisions to policies and procedures. He announced the district's involvement in two countywide initiatives: NJ Cares, which notifies the school of families in crisis, and P3 Campus, an anonymous reporting system. Dr. Moore concluded that he is proud to be working with so many talented people, and he would not want to work with any other group. He asked that community members join us to work together, sharing their passion and skills.

George Scott of the Traumatic Loss Coalition said he has partnered with Hunterdon Central for two years. He said the mission of the Board is education, and mental health initiatives were added on. He said he sees the suffering that children and families carry is a burden, and it is the school's responsibility to support that. Mr. Scott said he had spoken with a national expert who affirmed all of the work the district is doing. He said there is an uptick in suicide deaths of both students and adults. Mr. Scott cautioned that when you do this work to create healthy communities and lose a child, do not give up. He encouraged everyone to take a pledge to be indivisible; get scared, angry, and sad, but stay connected because we will only heal when we do not divide. All adults need to work together to make it a community of wellness, according to Mr. Scott. He concluded that we can celebrate our babies, and still stand by with a safety net to help those who need it.

RESIDENTS’ FORUM – GENERAL:

RESIDENTS’ FORUM

Acting Principal Ed Brandt recognized the retirement of Vice Principal Barbara Manfredi and thanked her for service since 1997. He reflected on his year as Acting Principal and the connections he has made with parents, community, the Board, student council, class council, and classes and groups that invited his participation.

Parent Cathy LaGullo expressed concern over the crisis in the community and the lack of communication and caring by staff and administration. She described children as terrified and angry. Ms. LaGullo said wellness seminars should be mandatory for students. She offered that many people are willing to partner with the school to be included in the solution. Ms. LaGullo concluded that she appreciates the school’s efforts, but asked that programs are more approachable for students.

Student Camryn Paulson said she applauds administration for its efforts, but she feels students do not understand what they are trying to do and things are not working. She said it is not natural for kids to be dying at 14 or 15. Ms. Paulson recommend school-wide workshops in the fieldhouse or auditorium and stronger relationships between students and administrators/teachers to improve mental health advocacy.

Student Amy Torres suggested ways to remove the stigmas around mental health such as talking about self-harm, mental health apps, and more inclusivity. She suggested a change to the school bell sound and more interaction with students through sports and clubs.

Student Emily Jerzewski told the Board that the school needs to talk more about mental health. She said she was 15 when her friend, Allison Vandal, committed suicide. Ms. Jerzewski said she is organizing a concert to benefit NAMI Hunterdon on June 19th to honor Allison, who was deeply involved in music. She also shared that it is important to include the pictures of classmates who have died in the yearbook.

Student Linda Nemec said she attended the Safe Harbor meeting and was inspired to write an email to the Board. She shared statistics about suicide and said that no immediate action was taken by the school following student deaths. Ms. Nemec said these problems are not just the school’s issue; everyone needs to help. She said students with mental health issues suffer from a loss of communication, no connection with others, stress, a large stigma, not knowing where to go, feeling pushed away by counselors, bullying, and social media. Student Destinee Dockhorn offered possible solutions such as implementing ideas from student advisory groups, peer mediation, no-phone Mondays, a peers-to-peers program, and curriculum changes to include mental health topics. Student Leah Ellenberg reported that suicide is the second leading cause of death for youth. She said suicide needs to end here; we are not going to wait for another student to die.

Student Sage Sorrentino expressed that the school’s work for mental health is not enough. She described the school as dull, dark, depressing, and cold. Ms. Sorrentino recommended solutions such as posters around school and gender-neutral bathrooms. She said LGBT students are at high risk and noted that she regularly hears homophobic comments. She criticized counselors’ offices as dark and bleak. Ms. Sorrentino expressed concern that students have too much pressure to perform well and need a break from homework on Fridays. She recommended mental health days for students. She concluded that Mr. Brandt has been very good for listening to students.

Student Kate Quinn said she is sorry for each person in the room for the grief they are feeling. She thanked the Board for its work and said she appreciates everyone coming to the meeting. Ms. Quinn recommended that school walls be painted with messages and bright colors. She offered that nothing is perfect and there is more work to do. Ms. Quinn concluded by reading a pledge from Safe Harbor.

Parent Elizabeth Drelich said she is proud of kids standing up at the meeting. She observed that there is a disconnect between Dr. Moore's presentation that sounds great and the kids who are still struggling. Ms. Drelich offer her unique services, as the mother of Joe Drelich, to help anyone. She said knew how much he was loved and how much he loved others, but when he took his life, he felt alone. Ms. Drelich said that hundreds who walk in the school doors are diagnosed with mental illness, and we need to lift the stigma. She said the solution is not to bring in counselors temporarily or to tell students to get over it. Ms. Drelich said a teacher was heard to say it was a good year – the school had only one suicide. She said suicide is a crisis in our country, and she urged that we be the leaders on change. She concluded that the children just want to be cared for and to know that they are not alone.

Former student Abbey Herdman said she lost two special people in her life to suicide. She said those left behind wonder why. She concluded that this is not the Board's fault, but something must be done now.

Parent Susan Hemsley-Cicala said she is sorry to see student and parents who are suffering. She offered that as a 58-year old, she is a genius at nothing, but an expert at living. Ms. Hemsley-Cicala said that no one goes through life unscathed; that is life. She told students that everything they are struggling with, adults have lived through. Ms. Hemsley-Cicala said suicide is bigger than a New Jersey issue or a Hunterdon Central issue. She asked how willing everyone is to stop what is going on now and start doing something about it. She advocated for changes to the yearbook and graduation to include the classmates who are gone. She concluded that kids have had fabulous ideas, and we need to talk about it.

Supervisor Annie Suter expressed hope and encouragement for Hunterdon Central students. She shared that staff and administrators care deeply for students and it breaks their hearts to see children suffer. She said her peers want successful, happy lives for students. Ms. Suter said staff was not taught all of this, that dealing with suicide is uncharted territory. Ms. Suter concluded that she loves and cares for this community so much, and she wants everyone to rally together to do the good work.

Teacher Julie Nealon said she is proud to hear her students advocate for themselves and proud that Carol Dvoor and Lesley Gabel are working for our students. She told students that people at Hunterdon Central care about them every day. Ms. Nealon concluded that those we have lost would be very proud of these students and are watching over them.

Student Assistance Counselor Stacy Heller said that we can get through this if we all come together. She discouraged divisiveness and holding on to anger. Ms. Heller shared a poem about the role of staff and encouraged adults to help quiet the negative, to help students grieve, and to work toward connectedness.

Student Amy Torres translated residents' comments to Spanish after each speaker.

Mr. Panico responded that he is on the Board because loves Hunterdon Central. He said it breaks his heart that others do not feel like he did as a student. Mr. Panico offered that a solution goes beyond the borders of the school, but we need to lead the fight. He thanked everyone for attending and speaking, and he assured that he hears the passion and drive in their words and he cares about all of them.
