



Hunterdon Central Regional High School Pay to Participate Program

Dear Students/Parents:

We are pleased that your child is planning to participate in an interscholastic sport and/or an extra-curricular activity. We hope that their participation will provide them with a very positive and rewarding experience. Please return one completed form and a single check for the entire family. **THE FORM BELOW MUST BE RETURNED WITH PAYMENT TO ENSURE PROPER CREDIT.**

1. Fee and Due Dates:

All participants on **Athletic Teams** (all levels), **Cheerleading** (all levels), **Pitt, Jazz and Marching Bands**, **Madrigal and Chorale**, **all Theatrical Productions**, **Dance Team**, and **Robotics Club** will be assessed an **annual activity fee of \$100**. Families with two or more students attending Hunterdon Central will pay a **maximum of \$200** annually. This fee covers participation in all sports and extra-curricular activities listed below for the entire school year for any high school student in grades 9 through 12. Fees collected are designed to help partially defray the operational cost of offering these programs. Parents and students should understand that this fee allows students to participate. It **does not** guarantee participation time in games, leads in performances, etc., nor does it ensure specific positions on a team. Those decisions will remain with the coaches and advisors.

Payment Due Dates: (Failure to pay by the due date could result in the student being excluded from participating in the activity.)

- **Athletic Teams** – After team selection, go to the HCRHS web site for final due dates: Athletics web page / Athletic Overview and Contacts
- **Cheerleading** – After team selection, go to the HCRHS web site for final due dates: Athletics web page / Cheerleading
- **Marching Band** – August 31
- **Madrigal/Chorale** – September 30
- **Pitt and Jazz Bands** – Prior to first official practice
- **Members of Theatrical Productions** – Prior to the first official practice
- **Robotics Club** – October 31
- **Dance Team** – September 30

The user fee is non-refundable: Any participant who leaves an activity or team voluntarily, or who is dropped for disciplinary or scholastic deficiencies, is not eligible for a refund.

2. Exemption for Federal Free and Reduced Lunch Program Students:

Students who are eligible for the Federal Free and Reduced Lunch Program are exempt from paying this fee. When returning this form please check the appropriate box below. The Board of Education understands that some families, due to financial hardship, may be unable to pay all or part of the extracurricular fee. It is the intent of the Board that no student is denied the right to participate due to the inability to pay. Should you need an exemption, please contact your class Vice Principal who will review your situation and make a determination. This matter will be held confidential.

3. Payment Process:

To ensure that your child receives proper credit for your payment, please fill out the bottom portion of this page and mail it with your check to the address below. All payments are to be made by **check or money order** payable to **Hunterdon Central Regional High School (HCRHS)**. Please note **P2P Payment** on the memo line of the check or money order. **If you are paying the maximum fee of \$200, list ALL of your children who attend Hunterdon Central.**
